#### **Continuing Education Courses Held Monthly**

PCG is now hosting live, virtual continuing education (CE) trainings on the last Wednesday of each month. Following each live event, all training content will be available online on <u>our website</u>. We hope you'll join us during the live sessions!

- **CEs for non-licensed providers:** Non-licensed providers can attend either the live training or view the recorded training. Each 1-hour training topic can be applied to the annual 12-hour CE waiver rule requirement. Certificates of completion will be emailed after the training has been successfully completed.
- **CEs for licensed professionals:** Licensed professionals (social workers, counselors, and RNs) MUST attend the LIVE training sessions in full in order to receive professional CEs. Trainings that are eligible for **licensed professional CEs** will be marked as such. Upon completion of the course and the required course evaluation, PCG will issue you a certificate of completion to ensure that you have the proper documentation needed for licensure.

## **Navigating Incident Management:** Assuring the Health and Safety of Individuals on the Ohio Home Care Waiver and MyCare Ohio Waiver

#### Wednesday 10/26/2022 2:00 pm via Teams Webinar

*This* training provides a deep dive into the Incident Management Rule, which identifies events that may cause harm to the individual, such as abuse, neglect, and exploitation. The training focuses on the provider's responsibility to ensure the Individual's health and welfare as a mandated reporter. During the training, we will also review the investigation process and the provider's role in that process.
